

TERMS AND CONDITIONS FOR STANDARD SUPPORT

This Standard Support Agreement (this "Agreement") is a legal agreement between you (either an individual or a single entity) and QNX Software Systems International Corporation ("QSS") for the standard support services that you have purchased from QSS ("Standard Support"). Services provided will be as described in the QNX Standard Support User's Guide (<http://licensing.qnx.com/standard-support/>) and in this Agreement. ANY USE OF STANDARD SUPPORT CONSTITUTES YOUR ACCEPTANCE OF THIS AGREEMENT. IF YOU ARE UNABLE OR UNWILLING TO AGREE TO THESE TERMS, CONTACT QSS IMMEDIATELY TO CANCEL YOUR STANDARD SUPPORT PLAN AND TO RECEIVE A REFUND OF ANY CORRESPONDING FEES YOU HAVE PAID.

You have requested a subscription to Standard Support for certain QNX Development Suite software that you have licensed from QSS (the "Software"). You are subscribing only to Standard Support for the Software listed on any corresponding subscription commencement or renewal invoices (the "Invoice"), subject to your payment when due of all applicable Standard Support subscription fees specified on that Invoice.

During your Standard Support subscription, QSS will provide you with "Help-Desk Services" for the current version of the Commercially Released Software by delivering person-to-person telephone-, email-, or web-based assistance with: (i) installation and configuration issues; and (ii) understanding the functionality and behavior of specific parts; and (iii) isolating problems you encounter by verifying the Software does not behave the way its associated documentation says it should on a corresponding Reference Platform ("Error"); and (iv) providing you with patches and work-arounds for known Errors; and (v) submitting problem reports for confirmed Errors that do not have current solutions. You may report and track your issues at Tech Support on the myQNX Portal. Help Desk Services are for your support and are not to be used for the benefit of other commercial QNX developers who have chosen not to subscribe to Standard Support. However, QSS reserves the right to publish information (including work-arounds and fixes) relating to any issues you report for the benefit of the QNX development community, provided it does not include any details that would identify you or your customers.

During your Standard Support subscription, QSS will provide you with any commercially released Media (6.x) and Minor (6.x.x) Software updates, as well as any intervening maintenance releases (including service packs and patches) (collectively, "Updates") for use in association with the corresponding development seat license. Updates do not include Major Software updates (e.g., QNX 4 to QNX 6) or access to unlicensed products or technologies. You may only use Updates that are released during your subscription to Standard Support. You may only use such Updates in association with your authorized Development Seat and licensed Target Systems, as defined in your applicable development license for the Software. You may not share your Updates with anyone else, unless they are entitled to use them under their own QSS license.

Your subscription will end on the anniversary of the Invoice date unless you first renew your subscription by delivering a purchase order to QSS for the Standard Support fee for the Software for the next subscription year. All subscription fees are due in advance and are non-refundable. QSS reserves the right to withhold Standard Support if you have not paid your subscription fees.

Limitations. The Software for which you have purchased Standard Support forms part of a general purpose modular realtime operating system. You will be selecting a subset of these modules for use in a unique hardware and software environment to achieve your desired functionality. QSS offers Standard Support to help developers identify and solve their particular Software development and implementation issues. Ultimately, you may find that you cannot achieve your desired results. While QSS is committed to providing versatile products, we do not warrant that the Software can be made to function in accordance with our user documentation, or other published specifications, in the case of every hardware platform, software

environment and configuration of modules. Bugs may be identified when you introduce the Software into your particular operating environment. You are responsible for rigorously testing the Software (including all Updates that you adopt) in the intended software and hardware environment before releasing any QNX-based products or updates thereto.

THE SOFTWARE AND SERVICES PROVIDED UNDER THIS AGREEMENT ARE PROVIDED "AS IS" WITHOUT ANY WARRANTIES OF ANY KIND, INCLUDING IMPLIED WARRANTIES AND CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT. NOTHING STATED IN THIS AGREEMENT WILL IMPLY THAT THE OPERATION OF ANY SOFTWARE WILL BE UNINTERRUPTED OR ERROR FREE OR THAT ERRORS WILL BE CORRECTED. OTHER WRITTEN OR ORAL STATEMENTS BY QSS, ITS REPRESENTATIVES, OR OTHERS DO NOT CONSTITUTE WARRANTIES OF QSS.

IN NO EVENT WILL QSS OR ITS AFFILIATES OR THEIR OFFICERS, EMPLOYEES, AGENTS, SUPPLIERS, DISTRIBUTORS, OR LICENSORS (COLLECTIVELY, QSS AND ITS REPRESENTATIVES) BE LIABLE TO YOU OR ANY THIRD PARTY FOR ANY INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES WHATSOEVER, INCLUDING BUT NOT LIMITED TO LOST REVENUE, LOST OR DAMAGED DATA, OR OTHER COMMERCIAL OR ECONOMIC LOSS, ARISING OUT OF OR RELATING TO ANY BREACH OF THIS AGREEMENT, ANY USE OF OR INABILITY TO USE THE SOFTWARE, OR ANY SERVICES PROVIDED OR INABILITY TO OBTAIN SERVICES, EVEN IF QSS HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGE OR CLAIM. IN NO EVENT WILL THE AGGREGATE LIABILITY OF QSS AND ITS REPRESENTATIVES FOR ANY DAMAGES ARISING OUT OF OR RELATING TO THIS AGREEMENT, WHETHER IN CONTRACT, TORT, OR OTHERWISE, EXCEED THE TOTAL FEES YOU HAVE PAID TO QSS UNDER THIS AGREEMENT FOR THE APPLICABLE SUBSCRIPTION YEAR. THIS AND THE PRECEDING PARAGRAPH SHALL SURVIVE AND APPLY NOTWITHSTANDING THE FAILURE OF ESSENTIAL PURPOSE OF ANY LIMITED REMEDY.

General. This Agreement is governed by and will be construed in accordance with the laws in force in the Province of Ontario, Canada without regard to the conflict of laws provisions therein. The parties expressly disclaim the provisions of the United Nations Convention on Contracts for the International Sale of Goods. This Agreement, including the QNX Standard Support User Guide which is hereby expressly incorporated into this Agreement by reference, constitutes the entire agreement between you and QSS pertaining to Standard Support and supersedes all prior or contemporaneous agreements, understandings, negotiations, and discussions, whether oral or written. No amendment or waiver of any term of this Agreement will be binding unless executed in writing by the parties. You are entitled to assign this Agreement to a third party who has provided QSS with a prior written acknowledgement of their acceptance of the terms and conditions herein. In such a case you will: (1) transfer to the assignee any support plan certificates, as well as all Update CDs (and associated licenses and documentation) received during the current term, and (2) destroy all copies of Updates received or downloaded under this Agreement during the current term. The provisions of this Agreement will inure to the benefit of and will be binding upon the parties and their respective successors and permitted assigns. If any provision of the Agreement is held by a court of competent jurisdiction to be illegal, invalid, or unenforceable, the remaining provisions shall remain in full force and effect. In the event of a conflict between the terms of this Standard Support Agreement and the terms of any document incorporated into this Agreement by reference, the terms of this Standard Support Agreement shall prevail.
